

## 2024 ASHTABULA COUNTY PAS (STATE FAIR TRY-OUT) ENTRY FORM

10:00 a.m. Sunday, June 23, 2024, Ashtabula County Fairgrounds, Jefferson, Ohio

Open to all Ohio 4-H members. No food available on grounds.

- Forms are due by 4:30 on June 19, 2024. Forms, documents, and fees will not be accepted, nor any changes made, after June 19.
- A [Horse Identification Form](#) must accompany the entry form.  
Fees are \$10 per class. Members may try out for an unlimited number of classes, but are limited to a maximum of four classes plus ground roping, at the Ohio State Fair Junior Horse Show. Make checks payable to: **Ashtabula County Saddle Horse Boosters**.
- A separate \$25 refundable stall deposit check must be included if the member intends to use an Arena Barn stall during the show. Payments must accompany the entry form and stall must be cleaned after use.
- Entry form, Horse Identification form, and applicable fees must be submitted to the Ashtabula County Extension Office, 39 Wall St., Jefferson, Ohio 44047 or [hoyt.88@osu.edu](mailto:hoyt.88@osu.edu)
- You must have a [PAS Out of County Approval Form](#) signed by your 4-H Educator to participate in another County's 4-H PAS Show.. Members may attend two PAS shows or one PAS show with two judges.

**The following information must be submitted BY 1:00 PM ON JULY 1, 2024 for the exhibitor to be eligible to compete at the Ohio State Fair Junior Horse Show:**

- Junior Horse Show entry and \$50 stall fee, submitted online at <https://ohorse.fairwire.com/>.
- Current negative Coggins test, dated on or after January 1, 2024, uploaded to the exhibitor's 4-H Online account.
- EquiSTEP Completion Certificate, uploaded to the exhibitor's 4-H Online account.
- Out-of-County PAS form (if applicable), uploaded to the exhibitor's 4-H Online account.

A member may participate in a minimum of two classes and a maximum of four classes (plus Ground Roping) at the State Fair Junior Horse Show, and will only be allowed to show in classes for which they registered and qualified. Members who intend to participate solely in ground roping must be enrolled in the Roping project book, and must submit their completed project book to the State show office for judging on the morning of the Ground Roping Class. Ground roping only entries will not be charged a stall fee. **Families should review the [2024 State Fair Junior Horse Show schedule](#) carefully for potential class conflicts.**

The Ohio State Fair Junior Horse Show prohibits showing in the following combinations of classes: Trail, Ranch Trail, or Trail-in-Hand; Intermediate Equitation Over Fences and Advanced Equitation Over Fences; Low Hunter Over Fences and Regular Hunter Over Fences.
